## Executive Summary

Recent trends show a growing interest among HBCUs and African higher education institutions (HEIs) to forge meaningful partnerships that transcend borders while advancing the capacity and long-term sustainability of both networks of institutions. Initiatives such as joint research and centers of excellence initiatives, faculty exchanges, offshore campuses, joint curriculum projects, twinning programs, executive leadership development, quality assurance and accreditation, technical and vocational education and training, and collaborative community engagement are emerging, but there is a pressing need for a structured platform to facilitate these efforts for the mutual benefit of both HBCUs and African HEIs to support areas of common challenge and opportunity (including financing models, digital infrastructure, enrollment management and faculty development). Against this background, the Historic African Diaspora Placement Program (HADIP) is partnering with the Association of African Universities (AAU), the African Capacity Building Foundation (ACBF), and the UNCF Institute for Capacity Building (UNCF) to organize around the theme: ***"From Dialogue to Action: Advancing Partnerships between Historically Black Colleges and Universities (HBCUs) and African Higher Education Institutions in Alignment with the Diaspora as Africa's Sixth Region,"*** which aims to move the dialogue to actionable strategies.

### **Breakout Session A: Cross-Atlantic Student Enrollment & Financing**

*Reimagining access and mobility for a new generation of globally engaged learners*

Over 6 million students studied abroad in 2023, with projections reaching 10 million by 2030 - yet African and HBCU student mobility remains disproportionately low. This pillar explores bold strategies to unlock access: reciprocal tuition models and regional scholarship funds to visa harmonization and digital credentialing. Participants are invited to co-design scalable financing mechanisms and mobility pathways that reflect equity, innovation, and the lived realities of today's learners. How might we build systems that not only move students, but transform institutions?

### **Breakout Session B: Curriculum Co-Design, Joint Research & Academic Innovation**

*Creating joint programs that reflect cultural relevance and international rigor*

Global curriculum reform is shifting from rote knowledge transmission to problem-solving, interdisciplinary learning, and cultural contextualization. This pillar invites participants to imagine joint degree programs, co-taught courses, and research collaborations that center African and Diasporic knowledge systems while meeting global standards. How can we design curricula that prepare students for the world—and shape the world they inherit? This session will ideate around prototype models that are inclusive, future-facing, and rooted in shared intellectual heritage.

### **Breakout Session C: Institutional Capacity & Business Model Development**

*Building scalable, sustainable infrastructure for partnership success*

According to the World Bank, institutional capacity is one of the most critical determinants of long-term development outcomes—yet many HBCUs and African institutions face structural constraints in scaling global partnerships. This pillar focuses on building the backbone: governance models, revenue diversification, digital infrastructure, and partnership management systems. Participants will engage in solution mapping around sustainable business models and capacity-building strategies that ensure partnerships are not just launched, but institutionalized.

Diaspora communities contribute over \$600 billion annually in remittances and investments globally—but their leadership potential remains underleveraged. This pillar explores how to activate Diaspora networks as strategic partners in education, innovation, and policy. Participants will co-create pathways for diaspora engagement that go beyond storytelling to systems change: leadership pipelines, advisory boards, and transnational innovation hubs. How do we move from symbolic inclusion to structural empowerment?
